IMPORTANT INSTRUCTIONS

The counselling for admission to UG NEET, Non-NEET Professional and Arts & Science courses for the year 2023-24 will be done by **CENTAC**.

The candidate seeking admission must apply online through **CENTAC** website (www.centacpuducherry.in) as per the schedule notified. Registration after the due date will not be entertained.

The candidate shall comply with all the instructions while filling in the application form.

The candidate seeking admission to any under graduate course must have completed H.Sc. from any recognized Board and must have passed in all subjects at the time of admission. For Lateral Entry admissions, Diploma qualification is required.

Admission is based on valid H.Sc. Academic marks, Age Criteria and Reservation Criteria of Government of Puducherry. Also, NEET score, JEE score and NATA score will be used for concerned seat allotment.

Please note that the candidature is subject to fulfilling the minimum eligibility requirements prescribed for applying to the concerned programme of study. In case a candidate does not meet the minimum eligibility criteria prescribed for applying to the concerned programme, it will be deemed to be done at the candidate's own risk and cost and if at any stage, it is found that if the minimum eligibility requirements are not fulfilled, the admission if granted, shall be cancelled ipso facto and the fees paid, if any, shall not be refunded in any case.

CENTAC will carry out only the allotment of the seats. The admission is subject to the approval of the Pondicherry University as per the norms.

The various terms and conditions mentioned in the Information Brochure are subject to the change made in the rules and regulations by the Government of Puducherry, affiliating University from time to time as per the decision of the Academic Council / Executive Council and also binding regulations/ directions of the Pondicherry University and other Regulatory bodies. CENTAC reserves the right to revise, amend, update, or delete any part of this brochure, as and when considered necessary.

1. INTRODUCTION

The Government of Puducherry has centralised the admissions for all NEET-based Under Graduate Courses, Non-NEET-based Professional UG courses, Arts, Science & Commerce UG courses and Diploma Courses in Health Sciences offered in the Union Territory of Puducherry under one umbrella and has designated Centralised Admission Committee (CENTAC) as the Counselling Agency. So, the counselling for allotment of candidates to courses for the year 2023-24 will be done by **CENTAC**.

CENTAC will conduct counseling for allotment of candidates to **Government quota seats, Self-supporting seats** and **NRI** available in **Government Colleges, Government Quota seats in Private Colleges**.

The scope of Counselling includes:

- i. All seats in Government Colleges offering Professional, Arts and Science, Fine Arts courses and Diploma courses in Health Sciences.
- ii. Government Quota Seats in Private and Unaided Professional Colleges, including minority colleges.

This centralisation makes it possible to offer all the information and services in one place making it easier for the students to access information and services.

The approximate number of seats, in the various courses for which counselling is done by CENTAC are listed in the table below:

4. MODE OF APPLICATION - ONLINE ONLY

Application must be submitted online **ONLY** through the website www.centacpuducherry.in.

Application forms submitted offline by post or other means will not be considered.

Mere registration does not entitle a candidate for allotment of seat. He / She must fulfill the conditions of eligibility prescribed for the concerned Courses.

Before filling the application, read the online prospectus/ brochure carefully.

The online application format and Information Brochure 2023-2024 may be downloaded for ready reference from CENTAC website. Candidate should ensure that all information entered during the online registration process is correct. Information provided by candidates like name of candidate, contact address, category, educational qualification, date of birth, etc., in the online application will be treated as correct and CENTAC will not entertain any request for change.

CENTAC does not edit / modify / alter any information entered by the candidates. But CENTAC reserves the right to update inadvertent errors in marks etc., entered by the candidates based on the records made available to CENTAC.

Refer website for the opening date and last date of online application to admission to various courses.

CENTAC may reopen the ONLINE application, depending upon necessity. Fresh Applications will be received whenever there is lowering of Cut Off marks or when there is lack of sufficient number of candidates or for any other reason.

5. STEPS FOR FILLING UP THE APPLICATION

1. All the candidates seeking admission to the under graduate courses based on H.Sc. marks(JEE for Self-supporting seats in Puducherry Technological University/PKIET, NATA score for B.Arch, NEET score for Health Sciences) are required to apply online on website www.centacpuducherry.in.

2. As a first time user, candidate shall create the login details as per the following steps:-

- On the “New Registration” page, candidate has to enter a valid Mobile Number and Email ID which would be used for any future communication for admission purpose. The candidate should take utmost care in providing the Mobile Number and Email ID, as all communications from CENTAC will be sent to the same.

- Candidate shall then create a new password (of maximum six characters) for online registration purpose. This password need not be the same as candidate's email account password, which is used to access one's email account.
- Candidate shall provide a valid mobile phone number (10 digit number without any prefix).
- Please verify that all the details given in the form are correct. This information will be used during the entire admission process. No change/modification will be allowed. Please be careful in filling up the required information in all aspect.

IMPORTANT : An OTP (One Time Password) will be sent to the candidate's registered mobile number during their dashboard login. All the candidates should carry their mobile handset with the same registered mobile number.

3. After successful registration the applicant shall login by using their "registered email-id" and "password" to fill the online application form.
4. Fill all the details in the application form.
5. Applicant shall upload the following documents (wherever necessary):-
 - i. Passport size photograph of the applicant (20 to 50 KB)
 - ii. Scanned signature of the applicant (20 to 50 KB)
 - iii. Self attested copy of High School/Higher Secondary Certificate/Birth Certificate for verification of date of birth (100 to 500 KB).
 - iv. Self attested copy of Mark sheet of the Qualifying examination. (100 to 500 KB).
 - v. Self attested copy of Transfer certificate from the school last studied (100 to 500 KB).
 - vi. Self attested copy of Residence / Community / EWS / Freedom Fighter / Ex-Serviceman/ Person with Disabilities/Sports certificates, if applicable (100 to 500 KB).
 - vii. Self attested copy of Regional Claim for Professional courses (100 to 500 KB).
 - viii. Self attested copy of Rural Claim for Arts, Science & Commerce courses (100 to 500 KB).

Note: The candidates are required to bring Printout of Application Form, Allotment letter and Original Certificates along with self attested photocopies of all the required documents at the time of Admission.

6. Once all the above-mentioned files are uploaded, applicant can proceed with "Make Payment". Applicant can also update the uploaded files and application form using "Back button" before making payment. Once payment is made, no changes can be made in the application.
7. The application submission process shall be completed only after making payment of the online application fee by the candidate.
8. Please note that the candidature is subject to the candidate fulfilling the minimum eligibility requirements prescribed for applying to the concerned programme of study. In case a candidate does not meet the minimum eligibility criteria prescribed for applying to the concerned programme, it will be deemed to be done at the candidate's own risk and cost, and if at any stage, it is found that the minimum eligibility requirements are not fulfilled, the seat allotted shall be cancelled ipso facto and the fees paid, if any, shall not be refunded in any case. Once the payment is made for the Application form, corrections, additions, deletions etc. in any manner shall NOT be allowed. The candidates are, therefore, advised to fill their forms carefully.
9. The candidate shall comply with all the instructions while filling in the application form.

6. ALLOTMENT PROCEDURE

Candidates seeking admission in professional courses and apply for the Government quota seats, Self-supporting seats and NRI seats in Government Colleges, Government Quota seats in Private Colleges should apply **Online** through the CENTAC website.

1. **Application must be submitted online only through the website www.centacpuducherry.in**
2. Before filling the application, the candidate should read the Information Brochure available in CENTAC website carefully.
3. The Information Brochure 2023-24 can be downloaded for ready reference from CENTAC website from **17.05.2023 (Wednesday)** onwards.
4. The last date for applying online is **06.06.2023 (Tuesday)**.
5. The candidates should ensure the following:
 - 5.1. Upload **recently renewed, scanned, self-attested photo copies of certificates**. Original certificates must be produced only at the time of **admission in the respective colleges**.
 - 5.2. All certificates produced in support of various claims such as Residence, Community, Regional Claim, Rural Claim, Freedom Fighter (FF), Ex-serviceman (ESM), Persons with Disability (PwD) & Meritorious Sports Persons (MSP), Christian / Linguistic Minority, NRI, etc., should be valid and obtained from the respective competent authorities.
 - 5.3. Regional Certificate must be obtained from the School last studied and counter-signed by the respective Revenue Authority.
 - 5.4. Residence and Community certificates issued by the Revenue Department, Govt. of Puducherry alone will be considered for claiming reservation benefits under Government / Christian / Linguistic Minority quota.
 - 5.5. Sports certificates must be countersigned by the concerned authorities.
 - 5.6. Rural certificate must be signed by the Head of the Institution of Government Schools, Puducherry. A list of rural schools has been provided in Annexure.
 - 5.7. Candidates who have studied in Lycée Français and opt for UG courses should produce an eligibility certificate issued from the Pondicherry University subject to the fulfillment of other eligibility conditions
6. Candidate should register and login to fill in all their details. Only on payment of application fee, the candidate will be allowed to enter his/her preferences of courses. Without filling the course preferences, the application will not be considered for allotment of seats. Candidate should bear in mind that the allotment of seats will be made based on the order of courses he/she has given as preference, subject to the availability, as per merit and reservation.
7. The candidate is advised to give as many choices of courses for which he/she is eligible in as many colleges as they wish. If a choice of course or college is not made, it will be deemed that he/she is not interested in the particular course or college.
8. The candidate should give their prioritization of course preferences in each round and the last date for submission will be published in CENTAC website. The candidate will not be able to edit his course preference after the last date. However, CENTAC reserves the right to permit all the candidates to alter their preferences, if required. The decision taken will be duly intimated to candidate from time to time.
9. Number of seats in the colleges may vary depending on the approval of the concerned competent authorities of the Government of Puducherry. The seat matrix and fees structure will be published

in CENTAC website after receiving the same from the concerned department of the Government of Puducherry.

10. Claim exercised with regard to Residence/ Community/ Special category are subject to verification of the submitted documents and cannot be changed once the **FINAL merit list is published**. However, CENTAC reserves the right to update the merit list in case of genuine claims supported by documentary evidences.
11. On verification of the candidates' credentials, the Draft Merit List will be published. Adequate time will be given to raise objections and submit documents, if any, and subsequently, the Final Merit List will be published.
Separate Merit Lists will be published for Government Quota Seats, Management Quota, Christian and Linguistic Minority Quota Seats. The candidate should refer to the CENTAC website www.centacpuducherry.in for the merit list.
12. Only **computer-based online allotment** will be done in Round I and in Round II. Physical counseling or online counseling might be done in the event of a mop up round.
For allotment of Government quota, vertical reservation will be implemented first and later horizontal reservation, if any, to the extent needed will be done.
13. Once the Provisional allotment list is published, the candidate must download the **Provisional Allotment Order** and report to the allotted college within the given time. If the candidate does not report within the given time, provisional allotment will be automatically cancelled. Similar procedure will be followed for the subsequent rounds of allotment as well.
14. Sliding will be allowed in Round 1 and Round 2. Sliding in mop-up counseling will be done only among the CENTAC allotted candidates. After Round 2, candidates who have been allotted seat elsewhere will not be considered for allotment.
15. **Enabling Provision:** If all the students of a specified category have been admitted, and even thereafter, if any seat remain vacant for that specified category, the same will be de-reserved as per the guidelines.
16. The candidate will be informed of all the proceedings of CENTAC through SMS / E-mail. The same will also be published in the CENTAC website and in the public media by way of press releases. After the online application is opened the students should refer to the CENTAC website www.centacpuducherry.in regularly, for updates.
17. All admissions made by CENTAC are "provisional" and are subject to approval by Pondicherry University and other affiliating bodies.
18. At any time, if the CENTAC / College or other Authorities find that admission has been offered based on false / incorrect information / documents and suppression of relevant fact, education qualification or quota, the allotment / admission offered will be summarily cancelled, irrespective of the stage of study of that course. Further, legal proceedings will also be initiated against such candidates for such actions. Hence, candidates are warned against indulging in such practices, in their own interest.
19. The original documents submitted by the candidates to be admitted in the respective colleges shall be returned only after obtaining recognition from the respective affiliating bodies, and hence, the candidates are advised to take enough numbers of photo copies of the documents before submitting the originals for verification.
20. The final authority to settle disputes, if any, in any matter will be the Chairman, CENTAC.

7. SUPPLEMENTARY CANDIDATES

Candidates who have appeared for the **supplementary examination** should not wait for the results but should apply online on or before the last date. However, such candidates should upload the photo copy of the mark statement of the qualifying examination within **FIVE days from the date of announcement of the supplementary result**.

8. SUBMITTING COURSE PREFERENCES

Candidates may login and fill in all their details along with course preferences. **Wherever Online (Computer based) counselling is prescribed, without preferences the application will be incomplete and will be summarily rejected.** Students should bear in mind that the allotment of seats will be made based on preferences subject to the availability of seats, as per merit and reservation. Candidates are advised to refer to the seat matrix for more details about the various courses, number of seats, reservations, etc.

Only after payment of application/processing fees, the students will be allowed to enter course preferences. Candidates should prioritize the preferences as per their choice, i.e., their preferences will be assigned serial numbers-1,2,3,4, etc. Candidates can change the priorities by rearranging the same.

Entry of New Preferences:

After each Round the Candidates may be required to enter new preferences, if it is necessary. In case, seats / courses are added during the counselling process, the candidate will be allowed to choose the preferences relating to the added seats / courses. Seat Matrix will be updated before the start of the next round and the candidates may have to refer to the Seat Matrix in order to fill the preferences. Videos uploaded in CENTAC website may be seen for further guidance.

Once preferences are given, they are final. However, CENTAC reserves the right to permit all the students to alter the preferences for the subsequent rounds. If such a decision is taken, the students will be intimated.

Students are advised to give as many choices of courses for which he/she is eligible in as many colleges as he/she wishes. If choices are not made, it will be deemed that he/she is not interested in those particular courses or in other colleges.

Choices once exercised with regard to community / rural / urban / special categories are final and cannot be changed once the merit list is published.

From Round II onwards once the candidate is allotted his preferred choice the earlier admitted seat will be forfeited automatically. Under any circumstances he/she will not be permitted to retain the earlier admitted seat.

9. MERIT LIST

The criteria for preparing the Merit List vary from course to course. MERIT LIST will be prepared based on the marks scored in the qualifying exams like NEET, JEE or based on the marks obtained in the qualifying exam. CENTAC may publish the MERIT LIST as Draft giving the candidates one or two days time to raise objections, if any. The Final Merit List will be published after considering the objections, if any.

Separate Merit List will be prepared for Government Quota Seats & Management Quota Seats. The students should refer to the CENTAC website www.centacpuducherry.in for the merit list of all the courses.

In case the ONLINE application is reopened for any course, then the Merit List will be updated with all the new applications received for the concerned course. This may alter the existing Merit List as well.

Cut-Off Marks

In case of NEET / JEE, Cut Off marks fixed by concerned authorities will be considered.

10. MODE OF RESERVATION

The Mode of Reservation while allotting the seats will be as follows:

- Vertical Reservation First - General, OBC, EBC, MBC, BCM, SC, ST, BT
- Regional Reservation (Compartmentalized Horizontal Reservation)
- Horizontal Reservation will be done if adequate seats are not filled after fixing vertical and regional reservation, i.e., if the requisite seats are not filled while doing vertical reservation, the last candidates in the respective category will be replaced as per merit.

An example of the method used for filling Horizontal Reservation:

If 5 seats need to be filled under Persons with Disabilities (PwD) quota and if 4 PwD Candidates are already accommodated in Vertical Reservation, then only 1 PwD Candidate will be pushed. If the 5th PwD candidate belongs to BCM, then the last Candidate in the BCM category will be replaced by this candidate.

11. MODE OF COUNSELLING AND NUMBER OF ROUNDS OF COUNSELLING

Counselling may be done in ONE or MORE Rounds depending upon the necessity. Typically counselling may consist of FIRST Round, SECOND Round, THIRD round and one or more Mop UP Round. CENTAC reserves the right to do more number of rounds in order to fill up the seats.

Allotment will be done through Online (computer-based) counseling. However, CENTAC reserves the right to do Physical (manual) counseling in any round including the mop up round. There will be no mock allotment unless notified separately.

FORFEITURE (REGISTRATION) FEE

CENTAC may also prescribe forfeiture fee (in case of MBBS, etc.) for participation in any round of Counselling. Where forfeiture (registration) fee is fixed, only those candidates who pay forfeiture fee, alone will be considered for counselling. Forfeiture fee will be forfeited in case the candidate fails to join the allotted seat.

12. MODE OF COMMUNICATION

All communications will be sent through SMS, E-mail, and updated in the CENTAC website apart from publicizing the same in the public media by way of press releases. After the online application is opened, the students should refer to the CENTAC website regularly, for updates.

Candidate must ensure that mobile numbers, e-mail address entered in the online application form are his/her own as CENTAC will send information / communication by SMS or email to registered mobile number and registered email ID only. It is advised that the candidate also registers an alternate mobile number to which he has got access.

No individual communication will be sent to any of the students / candidates apart from SMS / Email.

CENTAC or the Government of Puducherry shall not be responsible for any action / consequence/s resulting due to non-diligent follow up of notices, notifications and publications appearing on the CENTAC website by the candidates or not checking the SMS or email sent to the candidate.

CENTAC will not be held responsible for non-receipt of latest information due to wrong mobile number or wrong email address filled in the Online Application Form.

13. OPTIONS FOR THE CANDIDATES AFTER ALLOTMENT OF SEATS

Once the candidate has been allotted a particular seat, he/she can opt for one of the following preferences:

- i. The candidate shall download Provisional Allotment Order, Report to the college and after admission may ignore further rounds of allotment. In that case, this seat is not offered to other candidates.
- ii. *The candidate shall download Provisional Allotment Order, Report to the college and after admission and can opt for next round of allotment (Up-gradation / Sliding). From Round II onwards once the candidate is allotted his preferred choice the earlier admitted seat will be forfeited automatically. Under no circumstances he/she will not be permitted to retain the earlier admitted seat.*
- iii. The candidate shall download Provisional Allotment Order but without reporting to the college may participate in the next round of allotment. In that case the seat will be released and put up for the next round of counseling.
- iv. The candidate can reject the allotment and opt out of the next rounds of counselling.
- v. In any round, if the candidate not submit the course preferences, then it may be considered as the candidate not willing to participate in the round.

14. PROVISIONAL ALLOTMENT

All allotments of seats are provisional. CENTAC reserves the right to withdraw any allotment made at any point of time which does not fulfill the eligibility criteria / regulations fixed by the Competent Authority from time to time.

Eligibility / admissions / allotments made to and by the colleges shall be subject to approval of the regulatory bodies like MCI / DCI / AICTE / Pondicherry University / Apex Bodies, etc.

CENTAC and the Government of Puducherry reserve the right to make any verification as deemed essential at any point of time into the originality and authenticity of any of the certificates produced by any candidate to fulfill and stake his/her claim to any of the qualifying and eligibility criteria.

If, on such verification, it is found that the candidate has produced fake, fraudulent certificates or has obtained certificates by suppressing facts, he/she will be liable for criminal prosecution, immediate loss of allotted seat without any notice whatsoever, forfeiture of fees paid and levy of penalty as may be decided by the CENTAC and will be liable to be debarred from all exams / counseling in future; the authorities may also recommend blacklisting of the candidate to like MCI / DCI / AICTE / Pondicherry University / Apex Bodies and also cancellation of license.

15. JOINING TIME AND ADMISSION

Once the Provisional allotment is done, the candidate must download the **Provisional Allotment Order** and report to the allotted college within the specified time. If the candidate does not report within the given time, provisional allotment will be automatically cancelled, unless the time is extended by CENTAC. Similar procedure will be followed for the subsequent rounds of counselling.

The candidate has to produce the original documents to the college for completing the admission process. In cases where the candidate is not able to produce original certificates, the candidate should produce a bonafide certificate or give an undertaking to produce the original certificates to the college within the given time. In case of failure to produce the documents within the given time, the allotment is liable to be cancelled.

NOTE :An Internal Compliance Committee to deal with cases of sexual harassment on campus as per the Notification of the MHRD / AICTE dated 02.05.2016 and 10.06.2016, respectively, is in place in all the institutions.

16. De-RESERVATION

In case any seats in any RESERVED category remains vacant, the same will be converted into UNRESERVED seats and offered for counselling in Mop up round. In case of Regional Reservation, the seats will be first converted into the respective category and even after that if the same are not filled, then they will be unreserved. e.g., If a B.Tech. seat reserved for SC category in Mahe Region is unfilled then it will be converted into SC category seat with eligibility across the Union Territory and even after that if the seat remains vacant the same will be UNRESERVED to Mahe General category.

19. Documents For NRI / NRI Sponsored / OCI / PIO /Foreign Nationals Candidates

For claiming NRI/ NRI Sponsored / OCI / PIO / Foreign Nationals, candidates should submit the following certificates, whatever applicable.

- i. Candidate's parents resident certificate issued by the Embassy of that country complying with the Income Tax Rules / any other certificates to establish evidence that they are resident of that country / affidavit on Rs.100/- e-stamp paper to that effect.
- ii. Candidate's passport / VISA / Resident VISA.
- iii. Green card / Citizenship of the candidate.
- iv. If NRI Sponsored – with NRI Sponsor's acceptance certificate as Affidavit. (If applicable).
- v. Undertaking in the form of Affidavit from parent, if parent is not the Sponsor.
- vi. Income Tax Documents required as per the Income Tax Act 1961. (If applicable)

Note: For the purpose of verification e-document may be considered with regard to NRI ward certificate subject to submitting the original at the time of taking the admission.

20. NATIONALITY CRITERIA

A candidate seeking admission for Government Quota, Other State quota and Self-supporting quota through CENTAC should be an Indian National. However, French Nationals residing in the UT of Puducherry and covered by the terms of the Treaty of Cession shall be treated on par with Indian Nationals, for the purpose of admission to all the courses.

21. RESIDENCE CRITERIA_(Applicable for Seats in Govt. Colleges and Govt. Quota Seats in Private Colleges)

An applicant is considered to be a Puducherry resident if he/she is an **Indian National** and satisfies at least one of the following criteria:

- 1) The candidate or whose parent (either Mother or Father or Both) or Guardian (in case of children who have lost both the parents) has been residing continuously in this Union Territory for at least five years preceding the date of application.
- 2) Those who have passed the SSLC / HSC or any other public examination and for that purpose had undergone academic studies continuously **for 5 successive classes immediately preceding the qualifying examination** (including the year of qualifying examination) in a recognized educational institution located in Pondicherry UT and having their residence in Pondicherry UT for 5 years continuously during that period. **Mere stay in places such as residential hostel would not amount to residence.**
- 3) Children of natives of U.T. of Puducherry who have declared any place in U.T. of Puducherry as their home town and so certified by their respective Heads of Office. Nativity Certificate in the prescribed format has to be enclosed. (G.O. Ms. No. 64 dated 25th May 2006).

4) a) Children whose parents are Central/ State Government Servants/ Defense Personnel/ Central Paramilitary Forces/ Employees of Public Sector Undertakings wholly or substantially owned either by the Central Government or by the Puducherry Administration posted and serving in U.T. of Puducherry for at least a minimum continuous period of **three** years immediately prior to the last date of submission of application.

b) Children of the above said employees should have studied HSc of two years in any of the schools in the U.T. of Puducherry and should have passed the qualifying examinations (HSc) from the same school. (G.O. Ms. No. 04, Puducherry dated 09.02.2016 of the Chief Secretariat (Hr. & Tech. Edn.), Puducherry.

5. Children of Defence Personnel who were killed or disabled in action and children of Central Government Servants/ Pondicherry U.T. Government Servants/Defence Personnel/ Employees of Public Sector Undertaking wholly or substantially run either by the Central Government or by the Puducherry U.T. Administration who died while in the service in the Puducherry U.T.

6) French nationals residing in the Puducherry U.T. and covered by the terms of the “Treaty of Cession” shall be treated on par with the candidates who produce the prescribed Puducherry U.T. Residence Certificate. Such French Nationals will not be required to produce Residence Certificate; instead they should produce a “Certificate of Registration” issued for this purpose by the French Consulate at Puducherry. Children of these French Nationals shall not be considered for admission under the quota of non-resident.

All the above certificates will be scrutinized first by a committee appointed by the Secretary (Revenue), before final merit list is prepared. Tahsildars of various Taluks and Revenue Officers will be the Members of this Committee.

Note:1. Candidates seeking admission under U.T. of Puducherry resident quota must furnish the Residence Certificate from Department of Revenue & Disaster Management, Puducherry and renewed from time to time.

2. Children of French Nationals under clause 6 above, shall not be considered for admission under the quota of non-resident.

22. RESERVATION OF SEATS

Reservation in admission to various courses for the candidates of the U.T. of Puducherry belonging to different categories is as given below. Further, SC / ST / BT / EBC / MBC / BCM / OBC candidates are also eligible for selection under Open competition / General category in addition to the reservations made to them.

1. Scheduled Caste (SC)

Candidates claiming admission under this category should belong to a caste which is recognized as Scheduled Caste under “the **Constitution (Pondicherry) Scheduled Castes Order 1964**” dated 05.03.1964, read with “The Constitution (Scheduled Caste) orders (Second Amendment) Act 2002 (Central Act 61 of 2002) and should enclose the required certificate issued by an Officer of the Department of Revenue & Disaster Management, Puducherry, not below the rank of Deputy Tahsildar.

2. Scheduled Tribe (ST)

Candidates claiming admission under this category should belong to a caste which is recognized as Scheduled Tribe under “the **THE CONSTITUTION (PUDUCHERRY) SCHEDULED TRIBES ORDER, 2016**” dated 22.12.2016 and should enclose the required certificate issued by an Officer of the Department of Revenue & Disaster Management, Puducherry, not below the rank of Deputy Tahsildar.

3. Other Backward Classes (OBC), Most Backward Classes (MBC), Extreme Backward Classes (EBC), Backward Classes Muslims (BCM) and Backward Tribes (BT)

Candidates claiming admission under these categories should enclose the recent OBC / MBC / EBC / BCM / BT certificate issued by an Officer of the Department of Revenue and Disaster Management, not below the rank of Deputy Tahsildar.

4. Economically Weaker Section (EWS)

Economically Weaker Section is a subcategory of people belonging to the Economy based Un-Reserved category having an annual family income less than Rs. 8 Lakh and who do not belong to any category such as SC/ST/OBC across India.

Candidates claiming admission under this category should enclose the recent EWS certificate issued by an Officer of the Department of Revenue and Disaster Management, not below the rank of Deputy Tahsildar.

Note : Not applicable for ALL courses. Refer Seat Matrix in CENTAC website.

5. Freedom Fighter (FF)

Candidates claiming admission under this category should be Children / Grand Children of Freedom Fighters and they should enclose the necessary certificate issued by the Officer-in- charge, Freedom Fighters Cell, Government of Puducherry.

6. Wards of Ex-servicemen (ESM)

Those who are registered as Ex-servicemen in the Department of Sainik Welfare (DSW), Government of Puducherry and have got an Ex-servicemen / Widow of Ex-servicemen identity card from DSW should enclose the necessary certificate issued by the Director, DSW, Puducherry.

7. Persons with Disabilities (PwD)

The candidates seeking admission under this category should produce a full size photograph exhibiting the deformity.

a) Eligibility Criteria for Person with Disabilities (for M.B.B.S., B.D.S., B.P.T., B.Sc. (M.L.T. / M.R.I.T. M.I.T. / D.T. / C.T. / P.A.), B. Pharm. Courses)

For eligibility under the Persons with Disability Quota, locomotor disorder of lower limbs should be between 40% to 80%. For more details candidates are requested to refer to the BOARD OF GOVERNORS IN SUPERSESSION OF MEDICAL COUNCIL OF INDIA AMENDMENT NOTIFICATION No. MCI-34(41)/2018-Med./170045, dt. 04-02-2019.

b) Eligibility under Person with Disabilities for B.Sc. (Nursing) Course

- i. Persons with locomotor disorder of lower limbs between 40% and 50% only are eligible for nursing courses under the Persons with Disabilities quota, as per the norms prescribed by the Indian Nursing Council.
- ii. The disability should be certified by a duly constituted and authorized Medical Board comprising of at least three specialists out of which two should be of the specialty concerned and the candidate has to present himself / herself before the Medical Board. The last valid disability certificate of the candidate from a Medical Board should not be more than THREE MONTHS old from the date of submitting his/her certificate for disabled candidates.

Note :

- The candidates seeking admission to M.B.B.S./B.D.S./B.P.T./B.Sc.(Nursing)/ B.Sc.(M.L.T. / M.R.I.T. M.I.T. / D.T. / C.T. / P.A.) / B.Pharm. courses under this category will be required to undergo a second Medical examination by a Medical Board constituted for the purpose by the Director of Health and Family Welfare Service, Puducherry, to ascertain and confirm the nature and extent of physical disability.
- Candidates with any other DISABILITY other than the locomotor disability of the lower limb will not be considered for admission into M.B.B.S. / B.D.S. / B.P.T. / B.Sc.(Nursing) / B.Sc. (M.L.T. / M.R.I.T. M.I.T. / D.T. / C.T. / P.A.) / B.Pharm. courses under this special category. Such application will be summarily rejected without any intimation to the candidates.
- The certificates must be obtained within **three months** prior to submitting the application for seeking admission under the category. In case the certificate was obtained earlier, the application will be rejected. The medical certificate issued by the District Medical Board of the area concerned for this purpose is subject to the confirmation by the Director of Health and Family Welfare Service.
- The decision of the Director of Health and Family Welfare Service, Puducherry, in this regard will be final.

c) Eligibility under Person with Disabilities for B.V.Sc. & A.H. Degree courses

A candidate shall not be allowed for admission to B.V.Sc. & A.H. Degree course if he/she suffers disabilities in physical fitness (as mentioned in the Veterinary Council of India, Regulation 2016) as listed below,

- i. Disability of total body including disability of chest/spine more than 50%.
- ii. Disability of lower limb of more than 50%.
- iii. Disability of upper limb.
- iv. Visually handicapped candidates and those with hearing disability.
- v. Candidates with progressive diseases like myopathies, etc.
- vi. Disabilities which otherwise would interfere in the performance of the duties of a veterinarian.

The disability should be certified by a duly constituted and authorized Medical Board comprising of at least three specialists out of which two should be of the specialty concerned and the candidate has to present him/her-self before the Medical Board. The last valid disability certificate of the candidate from a Medical Board should not be more than THREE MONTHS old from the date of submitting his/her certificate for disabled candidates. In case the certificate has been obtained earlier, the application will be rejected. The medical certificate issued by the District Medical Board of the area concerned for this purpose is subject to the confirmation by the Director of Health and Family Welfare Service.

d) Eligibility under Person with Disabilities for other courses

For residents of Puducherry Union Territory suffering from not less than 40 percent of any disability as certified by the competent Medical Authority.

8. Meritorious Sports Person Category (MSP)

1. The highest achievement of the candidates in only one annual tournament under the listed sports disciplines in a year will be considered for awarding marks.

3. Participation / Achievements in sports / games shown in the list alone, immediately preceding **five** years to the year for which admission is sought will be taken into account. National / State Level Championships / Tournaments conducted by Organizations / Federations recognized by Indian Olympic Association / Ministry of Youth Affairs and Sports, New Delhi alone will be considered for award of marks (Recognition by the Indian Olympic Association / Ministry of Youth and Sports, New Delhi should be relevant to the years concerned).
4. Open /Invitational Tournaments of any kind will not be considered.
5. For Tennis Achievements of Top 3 players by his/her position in the ranking list published by ATTA based on the ranking rules and the final rankings of the previous 4 years will be awarded marks for achievements and participation (Necessary forms from Associations are to be enclosed).
6. For Cricket the Annual Official Championship / Tournaments conducted within the country under the auspices of the BCCI at the District / State National Level alone will be taken into consideration for that year.
7. The participation / achievements of candidates with nativity in the Puducherry Union Territory and who represented the Union Territory of Puducherry alone are eligible for marks under the National Category.
8. Union Territory of Puducherry candidates are eligible to apply for admission under the Sports Quota and candidates of KVS/NVS/CBSE Schools within Puducherry are also eligible for marks.
9. All the achievement certificates are to be supported necessarily by the relevant participation certificates and appropriate form /certificates.
10. No further enclosures of certificates will be entertained after the last date for submission of completed application.
11. A candidate can utilize the sports quota only once for these admissions.
12. The relevant attested copies of the certificates issued by the appropriate authorities as detailed in the G.O Ms.53 dt.24.05.2012 are to be submitted along with the application.
13. A committee will be constituted to scrutinize the applications received under this category and will rank the candidates based on the marks assigned to the certificate enclosed along with the application and the sports merit list will be published in the CENTAC website.

23. SPECIAL ALLOCATION OF SEATS (For U.T. of Puducherry candidates)

23.1 Special Regional Allocation for Karaikal, Mahe and Yanam in Govt. / Govt. aided Society Professional Colleges (Compartmentalised Horizontal Reservation)

The special allocation in admission to various professional degree courses offered by Govt. sponsored colleges, for the candidates of Karaikal, Mahe and Yanam regions shall respectively be 18%, 4% and 3% of seats earmarked to the candidates of Pondicherry Union Territory vide G.O.Ms.No. 99 dated 10.08.2006 of the Chief Secretariat (Education).Candidates claiming admission under this category should be a resident of the respective region, for a continuous period of 5 years prior to the last date of submission of on-line application.

To claim admission under special allocation from Karaikal, Mahe and Yanam regions, a candidate should have studied in the recognized schools located in the respective regions continuously for **three years**, immediately preceding the qualifying examination (including the year of the qualifying examination). Mere stay in places, such as, residential hostel would not amount to residence. They should produce a residence certificate from the competent authority not below the rank of Deputy Tahsildar. **These candidates should enclose the necessary certificate in the prescribed format only (Annexure-I)**

This certificate should be obtained from the Head of the Institution in which they studied, and countersigned by the respective Chief Educational Officers of Karaikal and Mahe Regions, and the Regional Administrator of Yanam Region. They should also enclose a residence certificate issued by an Officer of the Department of Revenue and Disaster Management, not below the rank of Deputy Tahsildar of the respective regions, clearly indicating the addresses of residence.

Note: Residence/Regional /Special allocation once claimed in the application will not be changed under any circumstances.

All the claims for the Residence/Regional/Special allocation should be made in the proper format and should be signed by the competent authorities specified.

23.2 U.T. of Puducherry Candidates in Self-Financing Colleges

The reservation as per the policy of the Government of Puducherry will be adopted for admission to the Government quota seats in self-financing professional colleges.

23.2.1 U.T. of Puducherry Candidates in Self-Financing Engineering Colleges

The allotment of seats for U.T. Puducherry candidates under various categories in Self-Financing Engineering colleges is as per the merit list prepared by CENTAC. (For Self Financing Quota), will be based on the NEET-2023 Examination and for B.P.T., B.Sc. (Nursing) and B.Sc. (M.L.T. / M.R.I.T. M.I.T. / D.T. / C.T. / P.A.) courses are as per the merit list prepared by CENTAC. The fee payable by the candidates admitted in the seats allocated in the Self-Financing colleges will be as per the recommendations of the Fee Committee.

23.3 Special Allocation in Arts and Science Colleges

23.3.1 In Arts and Science Colleges, out of 50% General seats, 10% is filled on merit for which other state candidates are also eligible.

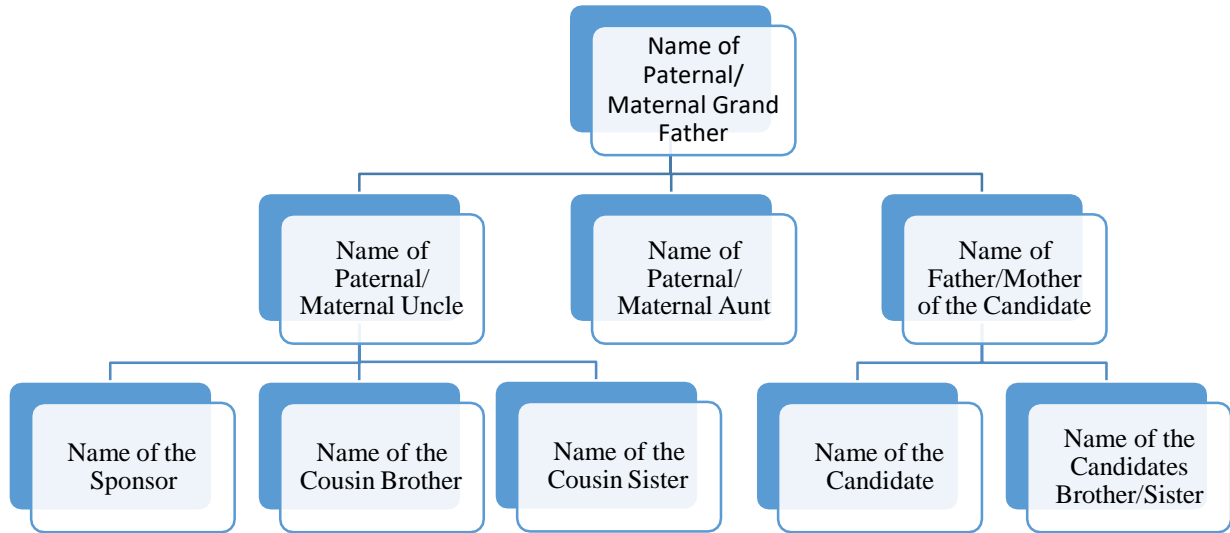

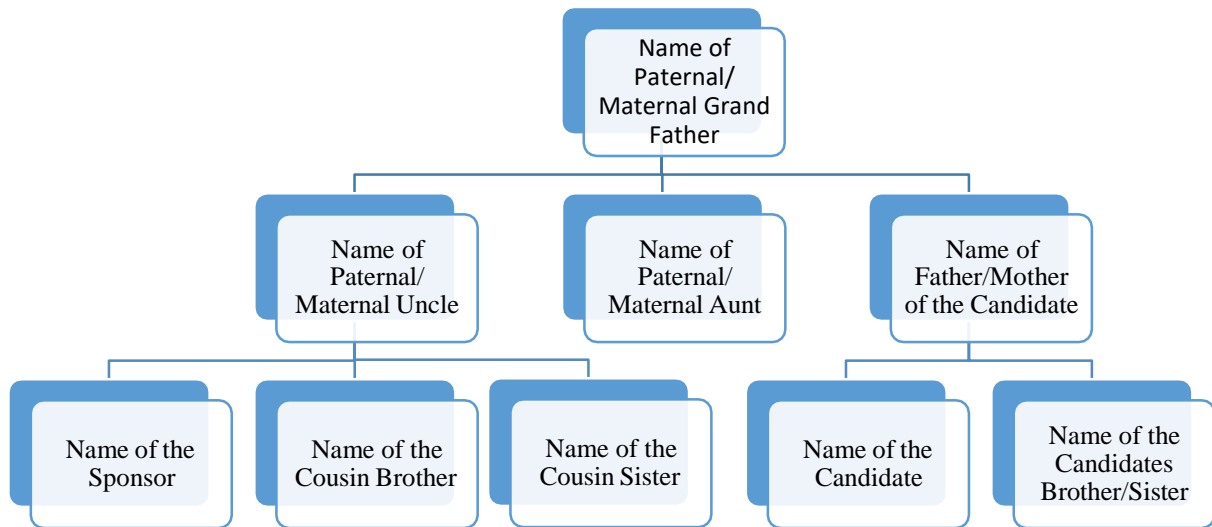
